These various scenarios are explained below.

#### Scenario One

If only a 3rd party Applicator is selected, that information will print below the Applicator Signature.

### Scenario Two

If a non-3rd party Applicator is selected on the ticket, the Applicator's license number/expiration date is displayed to the right of the Applicator's Signature line.

The non-3rd party Applicator's license number/expiration date will display to the right of the Applicator's Signature line.
