Admin

- **SV-2347 / Restrict Payment and 1099 Info Vendor Profile** – A new permission (*Add/Edit Payment Info on Vendor Profile*) is available in **SKY Admin** that, when enabled, will allow the *Payment and 1099 Info* section of a Vendor profile to be viewed and edited.
 - **Why** – This gives Admins the ability to determine which SKY Users can view and edit a Vendor's tax and bank information.
 - **When/Where** – The preference can be seen in SKY Admin when editing a User.
 - **Action Needed** – Ensure this permission is enabled/disabled for the appropriate SKY Users.

Customer

- **SKYW-4611 / PKI Booking Contracts** – PKI is added to the document as verification that the Grower has signed the Booking Contract.

Energy

- **SKYR-858 / Vehicles Maintenance Page** – View details of all vehicles in your fleet.
 - **Why** – To view a grid list of all vehicles and details for each.
 - **When/Where** – *SKY Energy / Maintenance / Vehicles*
 - **Action Needed** – No action required.
- **SKYR-977 & 1154 / Plot Tank Feature at Add/Edit of Tanks** – Plot a tank from the *Map* view overlay, when adding or editing, by selecting Plot Tank. [Read more!](#)
 - **Why** – To provide a precise tank plotting process through a Map view rather than having to know the latitude/longitude or a customer's address.
 - **When/Where** – On the *Tank Add/Edit* form.
 - **Action Needed** – The *Add/Edit Tank* permission needs enabled to use this feature.
- **SKYR-1061 / Budget Invoice View** – Navigate to *Orders / Budget Billing Invoices* tab and select any **Budget Invoice Number** to open a new Invoice details page. The new page includes Tank and Customer information (with *Customer Name* and *Tank Serial Number* redirecting to their respective pages with required SKY Customer access), Invoice details, Product details and Pricing information.

- **Why** – To provide an easy to read view of the Budget Billing Invoice details in SKY Energy.
- **When/Where** – *Orders / Budget Billing Invoices* tab.
- **Action Needed** – SKY Customer access is required to use the customer redirect links.
- **SKYR-1112, 1144 / Tank's Energy and Rental Split View on Add/Edit Tank Page** – Energy Billing Splits and Rental Billing Splits now have their own table view rather than being combined when viewing a Tank. Select the *Customer Name* and the system will route to the Customer page. Select the *Customer Attachments* option to view customer attachments.
 - **Why** –To view Split and Rental Billing information in an easy to read format and allow for access to additional information with Customer links.
 - **When/Where** – *SKY Energy / Tanks / Add/Edit a tank*
 - **Action Needed** – SKY Customer access and the Attachment permission is required to use the customer redirect and attachment links.
- **SKYR-1146 / Tank Energy Splits and Rental Billing Splits Allow for 4 Decimal Spaces**– Tank Energy and Rental Billing split details account for up to 4 decimal places.
 - **When/Where** – *SKY Energy / Tanks / Add/Edit a tank*
 - **Action Needed** – No action required.

Grower360

- **SKYW-4611 / PKI Booking Contracts** – PKI is added to the document as verification that the Grower has signed the Booking Contract.

- **HW-12202 / Zone Sampling** – Zone border lines display in Layers for Sampling Events with Zone Sampling made active. The SKY Soil Test report displays zone lines when the sampling surface is the Zone Sampling Interpolation type.
 - **Why** – If adjacent zones had the same result, the zones were not visible.
 - **When/Where** – This can be seen in Layers for Sampling Events with Zone Sampling made active as well as the SKY Soil Test report.
 - **Action Needed** – No action required.
- **HW-12421 / Rx File Import** – The Rx File Import works as expected.
 - **Why** – The Loadsheet and Product Rec Summary acreage were incorrect.

- **Action Needed** – No action required.
- **HW-12457 / Application Event** – The *Application Purpose* drop-down was added. The purpose of a given Application must be known (e.g., when a cover crop planting is terminated with an herbicide application). Among the initial values is Cover Crop Termination. To be consistent with Application Method and Timing, the new Application Event Attribute is surfaced.
 - **Why** – This addition supports sustainable carbon crediting.
 - **When/Where** – The drop-down can be found on the Application Event below Application Method and the Manual Application Rec.
 - **Action Needed** – No action required.
- **HW-12458 / Tillage Event** – New Attributes were added to the Tillage Event - *% Soil Disturbed* and *% Crop Residue Removed*. Like the other Tillage Attributes, these are surfaced and display in Layers.
 - **Why** – These values are necessary to track a Tillage Event to report their carbon footprint.
 - **When/Where** – These new fields can be seen on the Tillage Event below the depth as well as in Layers.
 - **Action Needed** – No action required.
- **HW-12464 / Create Event** – The import Create Event process works as expected.
 - **Why** – This process was originally causing an error.
 - **Action Needed** – No action required.
- **HW-12474 / Zone Tools** – All Rec Types display the *Non-Field Feature* as a *Source* option for the Zone Buffer tool as expected.
 - **Why** – This allows *Non-Field Features* to be a *Source* option.
 - **When/Where** – This can be seen when using the Zone Buffer tool.
 - **Action Needed** – No action required.

Web

- **HW-12397 / Import Boundary Agvance Integration** – The batch Boundary import process works as expected.
 - **Why** – The batch Field Boundary process was not working appropriately.
 - **Action Needed** – No action required.
- **HW-12467 / Chromeless Report Generator Font** – Font style changes are being reflected correctly in Reports.
 - **Why** – There was a font issue using the Chromeless Report Generator.
 - **Action Needed** – No action required.
- **HW-12501 / Merge Events Application** – Merging Event data includes all selected Events as expected.
 - **Why** – Merging Events was not including data from all selected Events.

- **Action Needed** – No action required.

Mobile

- **HW-12406 / Events not Requiring Season** – Scouting Events work as expected. Additionally, Events require a *Start Date*, and the app prevents clearing the *Season* on Events already created.
 - **Why** – Scouting Events were resulting in an error.
 - **When/Where** – When creating Scouting Events, the *Season* cannot be cleared.
 - **Action Needed** – No action required.
- **HW-12436 / Mobile Sync** – New logic was added to the mobile sync process.
 - **Why** – This update prevents duplicate payloads when adding Fields, Events, and Recs across poor network connections.
 - **Action Needed** – No action required.

Vendor

- **SV-2188 / Import AP PO into Autofill Bill** – Existing AP POs can now be referenced on Bills uploaded via Autofill.
 - **Why** – This allows the AP PO to be used on a Bill uploaded through Autofill and marked as *Processed* when the AP Bill is posted.
 - **When/Where** – This can be seen when editing a draft Bill uploaded from Autofill on the *Drafts* tab.
 - **Action Needed** – No action required.
